Where applicable, please include all measurable data.)	<p>IRAcademy currently offers the following Extended Learning Opportunities for our students: GEER grant for 3rd grade students, Rising K for our current Kindergarten students, A2- climate and Accelerate, Science through the Aerospace Lens for students in Extended Day, and Journalism for our Extended Day students.</p> <p>Our next ELO will primarily focus on 4th and 5th grade students who are currently in our lowest 35th percentile. We will offer opportunities of support in both ELA and Math. GEER and Rising K sessions will conclude on October 24th.</p>
Results of Action Taken:	<p>Our next steps will be based on the outcome of ongoing data monitoring and the Datacom on October 16th. Individual teacher data chats scheduled for November will also be used to determine next steps for student opportunities. We will also continue to use the Unify Assessments for our 5th grade students as a strong data point for success with grade level expectations.</p>
Reflection:	<p>IRAcademy is focused on student success of grade level expectations. Our ELO is to build upon strong classroom instruction for all students, filling in gaps that are barriers to success.</p>
