Evidence: Breakdown of fall sports teams (cheerleading, soccer and volleyball) by ethnicity; photos of the Book/Art Club which is part of our A2 (District's Initiative of Acclimate and Accelerate) offerings, and of one of our volleyball games, flyers for 2 other groups specifically targeted towards lower quartile ELL reading and math students before school. Students were sent an invitation to join the morning groups based on teacher analysis previous FSA performance. Announcement of basketball tryouts in November.

Results of Action Taken:

Teachers were given the opportunity in September to brainstorm remedial activities for students. A math teacher, an ESE (Special Education) teacher, and three reading teachers accepted the challenge. Both the literacy coach and math coach are offering the morning sessions.

Reflection:

We will continue to monitor student participation in these groups, and track academic progress for students participating in the academic enrichment groups to determine if their attendance is beneficial.


