Explanation of Evidence:	Microsoft Office e-mail meeting invitation, with induded agenda and names of individuals invited. All invited staff attended (one via Teams). As part of a regular meeting with the leadership and aspiring leadership team, the revised School Improvement Plan was reviewed. Connected with the SIP is the current student data as seen in Power BI. Department Chairs and Coaches were shown screenshots from Early Warning Indicators for 2019-20 as well as 2020-21, and discussed several noted areas of concern, both on the dashboard itself, and as part of the school's current SIP.
Results of Action Taken:	Leaders dissected the disparities between races with regards to discipline and a cademic achievement and brainstormed possible causes for these disparities. They were able to see the strength in data representation pulled from PowerBI and the ability to filter for grade and ethnicity as well as the ease with which they are able to see the overall data.
