Explanation of Evidence:	At the beginning of the school year, administration will provide teachers with baseline data on student performance on assessments. This performance data will be pulled from the school's information system, FOCUS. Teachers can use this data to identify African American students who are low-performing and begin strategizing how to meet those students' instructional needs. They can use the breakdown of how African American students performed on specific concepts to target standards. Some monthly department meetings will focus on data and teachers will share best practices on using formative assessments to determine which concepts should be retaught for African American students on their rosters. An example of baseline data for African American students that was shared with the English Language Arts and Mathematics Departments has been uploaded (A.A. Baseline FSA ELA Breakdown and A.A. Baseline FSA Algebra I Breakdown). Teachers will also utilize formative data gathered through iReady. Training on the iReady platform has been completed and the first round of formative assessments utilizing this platform is scheduled for 10/07/20 (iReady Training Email, iReady Sessions 10-07-20).
Results of Action Taken:	Some data chats have already taken place and will be a regular occurrence throughout the year. Classroom observations and walkthroughs will help administration ensure that data is driving instruction.
Reflection:	Currently, the school does not have access to all of the data harvesting software that the school district utilizes. Free and open access to this software could help the school collect more expansive data on performance.


