We have six African American students who are enrolled in Course Recovery during the day in Option 1 and one in Option 3: N. S, I.H., T.R., C.R., A.W., K.D., T.M., D.R. The documentation attached is from the Student Documentation tab in FOCUS showing counselor and graduation coach contact. During these meetings the counselors and graduation coaches regularly review graduation check status and progress through course recovery to achieve higher GPA and recovery credits missing that are required for graduation.
Results of Action Taken:	Added four new African American students to Option 1 course recovery and one to transitional period for work on course recovery since the start of the year. Graduation coach is meeting regularly with students to review status and set goals – short and long term.
Reflection:	We will continue to ensure equitable access is achieved by all students by providing in and after school opportunities for improvement and recover course failures.
