Assistant Principal meets weekly with guidance staff to discuss struggling AA students. Systems of support are discussed as well as any other options that would prove beneficial to the student. Power BI is used to monitor data as well as individual student conferences with guidance counselors.
Results of Action Taken:	Students have an adult on campus to help monitor academic progress as well as someone to discuss options when not academically successful.
Reflection:	This process remains fluid as students start to transition back to brick and mortar classes.
