The Leadership Team met during our weekly meeting to review data connected to our African American Students in grades 3-5 to compare previous FSA data with current district data to identify if there was a regression. Out of the 12 students reviewed the data that 3 out of 5 or 60% of regressed in ELA, and 4 out of 5 or 80% regressed in Math. These students have been invited to our ELO and will be a focus during our individual data chats with their teacher. 4 of these students are currently working virtually due to Covid 19 and we will continue to support them in any model they choose.

**Results of Action
Taken:** Results will be reviewed during the next data chat schedule for November and as new unify data comes in at the Leadership meeting.

Reflection: The barrier of having student in three different platforms has made the team look for ways to connect and have the students return to school asap. We also have a virtual 5th grade canvas course going for our African American students with 5 students involved. Attendance for this has been a challenge and we will continue to encourage and reach out to these families to ensure the students are logging on and working with their teacher.
