- Follow up by ALTOSS Staff and SDIRC Staff (Leslie) expectations

FOCUS

- Who should we report discrepancies to (I.e. number of days referred ALTOSS does not always match number of days of discipline on the ODR).
- Data sharing/cross referencing when, if any, are reports needed for district purposes?

Info to disseminate to schools:

- 6th to 12th grade only
- Minimum 2- or 3-day attendance at program
- Attendance: mark ALL days assigned as "V" and we will notify of non-attendance or tardy
- Admin to call/email program staff and/or have parent call to get program info this may assist with no-shows
