| Results of Action Taken: | As a result of implementation of MTSS for students that were retained or needing immediate attention, small groups instruction with ELA interventionist and School Counselor will begin the first week of October. Kindergarten students showing high need were offered participation in the Rising K after school program. Student lunch groups were also started for Social Emotional Learning with our School Counselor, based on MTSS needs that have been identified from last year and continued for the beginning of this year. Based on administrative walkthroughs, small group tier one instruction is occurring in 100% of the general education classrooms. ** no new updates since the September submission |
| Reflection: | As teachers and students begin small group instruction focusing on ELA, Tier 1 and RtI will also include books with culturally responsive subjects appropriate to the grade level that will increase academic learning as well as cultural sensitivity. |
