**Explanation of Evidence:** Evidence includes a data chart of the number of students who have received in-school suspensions thus far. Additionally, summaries of student discipline referrals are included to demonstrate the reasons students spend time in this classroom. Overall, we have 155 referrals in FOCUS. Of those, 121 are “minor infractions” which are documented by classroom teachers, and don’t involve administrative consequences or interventions. So this means there are only 34 actual ODR (office discipline referrals) which do require administrative consequences or interventions. Compared to the 19-20 school year, we had 114 ODRs at this time.

**Results of Action Taken:** With the implementation of the Student Success Coach position this year, Mr. Ken Brown, we have taken a more proactive approach to discipline, and we have encouraged teachers to address situations immediately in their classrooms wherever possible through positive interventions and supports. Mr. Brown visits classrooms and provides feedback and suggestions to teachers who are having trouble with individual students, or with classroom management for particular periods. He has put some students on behavior point sheets which has proven extremely successful. He has been instrumental in reducing the number of office discipline referrals through his interaction and involvement with the students on a one-to-one basis. We have eliminated the “buddy classroom” system in which teachers would send an unruly student to a neighboring teacher’s classroom.

**Reflection:** In addition to our placement of Mr. Brown as the Student Success Coach, we have Mr. Harvey Lee in our ISS room, which has been renamed our Resource Room. Mr. Lee is an ESE Support Facilitator, so when and if students go there, they receive not only behavior support, as he was previously a Behavior Intervention Specialist, but also individualized academic assistance with the classwork they are doing, as he is also a Special Education teacher. Mr. Brown and Mr. Lee and fatherly advice that they are able to provide many of our students at this crucial time in their lives, we feel, is encouraging many of these students to make better choices going forward.










## Total Suspension Days by Race/Eth



## Average Suspension Length by Race/Eth




## Total Suspension Days by Grade
