

School District of Indian River County African American Achievement Plan 2020 -2021 Assurances of Implementation of Action Steps



In August 2020, the School District of Indian River County initiated the implementation of the 2020-2021 African American Achievement Plan. To review and ensure compliance with progress of action steps associated with the African American Achievement Plan, the District provides quarterly updates related to action steps accomplished and quarterly outcomes. Following the first quarter of implementation of the African American Achievement Plan, it became clear that increased time and effort should be invested in action step implementation in comparison with compliance activities. As such, the system associated with submitting evidence of the implementation of action steps was analyzed and revised to maximize the allocation of human capital and resources towards supporting students and staff in eliminating the achievement gap.

The attached documentation provides school level evidence of progress towards accomplishing action steps incorporated into the African American Achievement Plan. Documentation requirements have been designed to honor the full intent of the developed African American Achievement Plan while optimizing the efficiency and effectiveness of outlined actionable steps.

To support ongoing accountability of action step implementation, documentation, and progress the following assurances have been verified by the principal of each school:

- Action steps included within the 2020-2021 African American Achievement Plan have been implemented with consistency and purpose to eliminate the achievement gap.
- Progress related to action steps has been monitored at designated intervals (e.g., monthly, quarterly) outlined in the African American Achievement Plan.
- Data reviews have been conducted to identify areas of strength and concern and disaggregated data will be provided upon request.
- Progress related to the elimination of the achievement gap has been monitored in an ongoing way and needed modifications have been made as identified.

Here is ace reporter Julia Julian with an inside look at how Motown got started.

Julia.

THANKS TITTO!

We here at IRA think that the music of Motown was an excellent choice to feature this month.

Motown featured primarily African American artists. It achieved success with a sound and popularity that reached across racial lines during a time when much of the country was still segregated.

Motown had 110 top 10 hits from 1961 to 1971. Its artists including names such as Smokey Robinson, Gladys Knights, The Temptations, Stevie Wonder, The Jackson 5 and Sammy Davis Jr.

What do you think of that Titto?!

I did some research to Julia and I found out that Motown was founded by a a man named Berry Gordy.

Berry Gordy Jr. was born in 1929. He tried many careers -boxing, record store owner and even served in the Army during the Korean War but his passion was the entertainment world.

Berry became a gifted song writer but was not content just writing songs. He burned with the desire to be an entrepreneur so with an \$800.00 loan from his family he set out on his journey to make his dream come true. He envisioned a process by which a kid could walk in one door an unknown off the street and come out the other a polished performer. Berry started his empire on West Grand Boulevard know as Motown records.

Julia our reporting is on fire. It's getting SMOKEY in here.

Titto, I think what your trying to say is that when you speak of Motown royalty, one of the first artists that comes to mind is Detroit's own SMOKEY Robinson.

William Robinson Jr was born February 19, 1940 but has been called Smokey most of his life. He became a songwriter, producer, singer and Motown records executive. He also founded the group The Miracles.

Smokey helped Berry build Motown and was the lead singer of The Miracles. The Miracles first hit song was "Shop Around" and another popular tune was Second that Emotion.

Such accomplishments for Smokey.

Oh my gosh Titto! I just looked at the clock do you know what time it is???

That I do Julia.

It's time to catch that Midnight train to Georgia!

Gladys Knight and the Pips came to Motown as a group that performed together since the 1950s. They were a family group made up of Gladys, her brother Bubba and their cousins William and Edward. The group scored hits with other companies but really took off when they signed with Motown Records in 1966.

The group released Midnight Train to Georgia in 1973 and they won a Grammy Award in 1973 for their single Neither One of Us.

Wow, so much talent in Motown! What a temptation it must have been!

What do you think JJ??

J]??

Well TJ Temptations await!

Known for their fancy footwork, vocals and showmanship, The temptations are a major influence on R & B and soul music.

Like their first Top 20 hit in 1964, "The Way You Do the Things You Do," no other group could do the things the way the Temptations did.

With support from Motown, the Temptations excelled. Their iconic song "My Girl was written by Smokey Robinson and Ronnie White.

The information from the Cub Club just keeps coming.

I WONDER who's next?

Well since you asked Miss Julian it's time to cover Stevland Hardaway Morris better known to his fans as Stevie Wonder.

Stevie Wonder is one of the most successful songwriters and musicians in history.

Blind since shortly after he was born, Wonder was a child prodigy know as Little Stevie Wonder, leading him to sign with Motown at the age of 11.

Stevie has sold over 100 million records worldwide. He was the first Motown artist and 2nd African American musician to win an Academy Award for Best Original Song.

Stevie has a star on the Hollywood Walk of fame, has been named a United Nations Messenger of Peace and was honored with the Presidential Medal of Freedom.

What an inspiration to us all.

So far, we have covered 5 super star success stories. Does the number 5 bring anyone else to mind Julia?

Hmm, let's see. Let me go through my ABC's and 123 4 5

Of course, the Jackson Five!

The Jackson 5 was founded in 1965 in Gary, Indiana and included brothers Jackie, Tito, Jermaine, Marlon and Michael.

The Jackson 5 signed with Motown in 1967 where they were the 1st group to have 4 number one hits on the Billboard Hot 100.

The group has sold more than 100 million records, they have been honored with a star on the Hollywood Walk of fame.

Two of their songs including ABC are among the Rock and Roll Hall of Fame's 500 songs that shaped Rock and Roll.

In 1971 Michael Jackson appeared on the cover of Rolling Stone Magazine. This was another breakthrough for African Americans in the music world.

So much talent, so much history. Where and who should we end with.

We would like to finish our reporting with our musician in the spotlight.

You got this Titto?

I do Julia.

What an honor to finish up with a man deemed "the greatest entertainer to ever grace a stage in the United States".

That's right I'm talking about Mr. Sammy Davis Jr.

Sammy signed a brief deal with Motown in 1970. He worked with other record labels and entertainers over the years.

Sammy started his career at the age of 3 with his father in vaudeville. Sammy was a singer, dancer, actor and comedian. He also served a stint in the military. Sammy's popularity helped break the race barrier of the segregated entertainment industry. In 1987 he toured with big names like Dean Martin and Frank Sinatra. Sammy even had his own television show.

Sammy was given an Medal by the NAACP and was nominated for a Golden Globe and Emmy ward for his television performance. In 2001 he was awarded the Grammy Lifetime Achievement Award.

Some of Davis' songs have been featured on Broadway and in movies.

That about wraps up our history of Motown artists. We hope you enjoyed our reporting.

Look Julia what kind of candy do you want? Sweet chocolate, chocolate malted candy, gumdrops? Anything you want! You've come to the right man Julia, because I'm the Candy Man
