Summary of Action Steps / Plan based upon District Impact Review (based upon District & School Level Reviews):	*Teachers reviewed data from predicted scores in Power BI, reviewing not only achievement, LG, and BQ LG. This will continue to happen with teachers every 6-8 weeks. Teachers reviewed i-Ready scores to make adjustments in their groups. They will review kid-by-kid in data chats before Spring Break with any changes occurring as of 4/1.  *Administration/SLT will review the BQ students and students who are not expected to maintain a 5 with teachers They will identify those students who need to structured check-ins on a bi-weekly basis. Admin, front office and specials teachers will select 2 students from either group to focus in on and mentor *Student Data Conversations focused on their academic/ attendance data. Teachers and students will review data, and review what support is needed and what students need to do to achieve their goals. A specific protocol will be used for each student.  *Administration will create a list (by teacher and grade level) of the BQ kids for their clipboards, so that as they walk rooms in Grades 3-5, they can put an extra set of eyes on students to ensure they are working towards success.  *Leadership team will review Tier 2 interventions and A2 interventions using attendance data, progress monitoring and Tier 1 assessments to see if the intervention is getting the desired outcome. In March use new POWER BI predictions to see if any changes need to be made after Spring Break.


