STATUS OF Schools in Indian River



SAFETY & INSTRUCTION

- Altered health & safety protocols
- Ongoing consultation with the Department of Health, school health officials, and local physicians
- Three instructional options: Traditional Return to School, Indian River Virtual School, Transitional Distance Learning


On Monday, July 7, 2020 an Executive Order was issued indicating that all Florida school districts must offer a 5-day, brick & mortar option as part of their instructional models during the Fall reopening.

SDIRC INSTRUCTIONAL OPTIONS



Option 1: Traditional Return to School

- Available to students in grades PK-12 with and without disabilities
- Upon school reopening, students return to their choice/magnet school
- Modifications in the use of school space, safety procedures, & transportation is based upon the level of COVID-19 spread





Option 3: Transitional Distance Learning

- Available to students in grades K-12 with and without disabilities
- Pre-kindergarten students with disabilities also have this option available
- Upon school reopening, students receive instruction through a distance learning platform that operates in coordination with a student's choice/magnet school
- Semester commitment

Instructional Model Selections



Based upon the current trend of instructional model selection, approximately 80% of students will be returning to a brick & mortar setting in August.

Extended Deadline for Instructional Model Selection: Friday, July 17, 2020 Students/families who have not selected an instructional model by this date will be scheduled for a traditional return to their choice/magnet school.




- Increased seats available for school choice

- Significant revision of the Code of Student Conduct to emphasize & implement proactive & equitable disciplinary alternatives
- Transformation of the Alternative to Out-of-School Suspension Program into a true disciplinary alternative
- Required district approval from Deputy Superintendent for the assignment of out-of-school suspensions
- Development of platform for monitoring students with disabilities suspended for >10 days
- Ongoing monitoring of discipline removals by subgroup
