The plan provides recommendations on how a school district will modernize, renovate, or replace its facilities to enhance the district's academic programs and educational requirements. The overall goal is to create and provide a comprehensive educational experience for each student in a safe, engaging and challenging environment.

Both the process and documents are designed to ensure the master plan is developed through a partnership of both the district and community. It will serve as a guide for assessing the need for facility improvements to support on-going district, student and community educational requirements. A master plan is not just about designing buildings; it encompasses aligning with district educational programs and student and community needs. A full comprehensive master plan can take 12-18 months with a consultant. The district's plan is to complete a high-level conceptual master plan in less than a year in-house.
