Results of Action Taken:

As a result teachers are aware of the students' performance on iReady Diagnostic data, subgroup performance and needed interventions. Tier 2 and Tier 3 interventions will be implemented and progress monitored. Impact walks and district data reviews will be conducted next week.

Reflection:

We are finding we need to be creative in scheduling to ensure all interventions are able to be implemented as needed. We noticed teachers are becoming more aware of subgroup performance and can talk about specific student performance.

Action Step 1.12 - Student Progress Monitoring

Initial data meetings reviewed iReady Diagnostic results to determine tier 2 and tier 3 interventions.

Also identify areas of achievement gaps in our African American subgroup, identify specific students, and plan intervention supports.

Our Impact Walks will be conducted Oct. 13th and we will then do another review of data, including unit assessment data to progress monitor student performance and create an action plan for next steps in instructional supports. District Data Com meeting will be held Oct. 16th for data analysis and action planning.
