Explanation of Evidence:

Our students do not get suspended from our campus so we do not look at suspensions from school. We also do not utilize the In School Suspension process so those topics are not discussed. We do address absenteeism and regularly discuss progress toward goals. Due to cognitive challenges, the majority of our students are not on track to receive a typical diploma but it is our goal to ensure that they "Graduate" All of our students have Individualized Education Plans so we are constantly referring to those documents for accomplishment and need.

Results of Action Taken:

As a result of our continuous data chats happening every two weeks and our constant work in alignment with IEPs, we are able to be very purposeful and timely meeting our students individual needs and reassessing expectations.

Reflection:

By utilizing ALL of our human resources, Wabasso is able to provide specific service to our students as should be expected in Center School.

Mentorship Log (Confidential) but at risk African American students have been paired with an adult on campus with a goal of meeting face to face (with a documentation log to be reported to multicultural committee) at least once a week.
