| Reflection: | Students will work on credit recovery during and after school. Three sections of course recovery have been included in VBHS's master schedule in accordance with the AAAP. Forty-three students are currently enrolled in these classes and working toward recovering credits from previous course failures. SAT test prep session will be offered with transportation weekly leading up to the school-based SAT. Counselors will meet with seniors to map out what they must do to graduate. The grad coach will be provided a copy of the plan. |
