Professional development with teachers took place around understanding changes to the new SDIRC Student Code of Conduct. Included in this professional development was a focus on the need for principal supervisors' approval for all OSS and the importance of classroom management, parent communication, and documentation. In addition, our success coach has implemented school-wide tier 1 PBiS supports and targeted tier 2 and tier 3 support for identified students based on past ODR, ISS, and OSS data in order to be proactive instead of reactive. This includes check-in/check-out, SEL skills support, Restorative Justice practices, and relationship building.

Results of Action Taken:

There are currently zero ODRs that have resulted in OSS, nor any that have been sent for approval.

We are grateful for our PBiS support and the preventative work being done to support student behavior. We look forward to continuing this process for a successful year of in increased positive climate and culture as well increased time in the classroom for identified students.






