**Summary of Action Steps/Plan Based Upon Problem Solving Session(s) for Achievement:**  
Achievement disparities are addresses through teacher data chats, explicit planning for BQ students and those falling behind, coaching cycles to support teachers addressing these needs, Multi-cultural coordinator conducting pull out and push in support of needy students (data-based), after school and during school (mornings, lunch) tutoring. Behavioral disparities are addresses through tier 1 and 2 support in classroom by teachers, tier 2 and 3 support by success coach, multicultural coordinator, ASPIRE teacher, guidance counselor, and administration. This includes CICO respite pass usage, classmanagement support is provided. Restorative justice practices, goal setting with students counseling, parent consultations and collaboration with peer counseling. social skills, mental health referrals and more as student needs.
