In September 2022, the School District of Indian River County initiated the implementation of the 2022-2023 African American Achievement Plan. To review and ensure compliance with progress of action steps associated with the African American Achievement Plan, the District provides quarterly updates related to action steps accomplished and quarterly outcomes.

Based on the current data we will continue supporting our students through opportunities for tutoring. Using the data from Quarter 1 we identified a need to increase those opportunities and have created a "lunch availability" opportunity for those students needing extra time/support in getting course recovery or classwork completed. This is an everyday opportunity. In addition, we will continue to identify and support those students that are becoming "chronic" in absenteeism. Our support in this area has reflected in slight improvements for several students and we hope to increase that success. We will continue to advertise and offer support for African American students to participate in extracurricular activities.




