In September 2022, the School District of Indian River County initiated the implementation of the 2022-2023 African American Achievement Plan. #### **Quarterly Reflection**

Quarter 3 our leadership team and school counselors devoted a significant amount of time supporting students at risk of failing based on current grades and previous course failures. We increased enrollment in our A2 afterschool tutoring program specifically targeting unique needs. In addition, we focused on improving student ADA. We identified students through the MTSS process, held meeting with individual families, and wrote attendance contracts when needed. Finally, we restructured our PBIS program, and have seen improvement in student participation and rewards distributed.
